SCHOLORSHIP/ FREESHIP POLICY



Uran Education Society's College of Management & Technology is deeply committed to fostering and empowering the most promising minds, guiding them towards a path of perpetual learning and leadership. In recognition of exceptional academic achievers with immense potential, the College provides substantial scholarships that cover either a portion or the entirety of the academic fees for the entire duration or a specified period of the program. This policy has been meticulously crafted to facilitate the seamless management of scholarships, freeships, and other forms of financial support available at the College.

POLICY

- The eligibility for Fee Concession is restricted only to the Students from Uran Education Society's College of Management & Technology.
- The Fee Conces sion will be restricted to the extent of Tuition Fees, Term Fees, Development Fees and Sports Fee only. Any fees that are in the nature of reimbursement to the University/ Education Board / Insurance Premium/ Admission Form etc., will not qualify for concessions. However, The Management reserves the right to amend the said rule as and when required.
- If the student is availing fee concession facility, then eligibility would be decided on the basis of performance of the student in the previous/ qualifying examination and economical condition of the parents. During subsequent years, the fee concession facility would be continued subject to the improvement in academic performance of the student in the class for which fee concession was offered.
- The college is committed to reaching out to donors and urging them to extend scholarships to students in need who demonstrate merit.
- Furthermore, the college will actively inform students about the diverse range of scholarships available, along with the application procedures and eligibility criteria.
- For government-sponsored scholarships, the college will adhere to the eligibility criteria outlined in government policies.
- For all other scholarships, the eligibility criteria will be established by the college scholarship committee, in consultation with the donor where applicable.
- Corporate-sponsored scholarships will follow the eligibility guidelines set forth by the respective corporate entity.

- A selection committee, comprised of faculty and administrative staff, will be formed by the college. This committee will be tasked with the solicitation, collection, and thorough examination of applications. Upon consultation with the principal, they will put forward recommendations for consideration.
- The committee's decisions will be conclusive and binding.
- Each student will be entitled to only one scholarship per academic year.
- Scholarship funds will be either directly deposited into the students' bank accounts by the awarding entity, or if the amount is disbursed to the institution, it will promptly be issued to the students via check.
- Should it come to light that a candidate has provided inaccurate information or details
 in their application, or has engaged in misconduct, malpractice, or violated college
 policies, disciplinary action will be initiated and the awarded scholarship may be
 withdrawn back.
- In situations where candidates are equally qualified, preference will be given to female students and individuals from marginalized segments of society.

Eligibility Criteria:

Free ship will be provided to the students who will met the given Criteria-

- A student should have 75% Attendance
- Academic Result must be min. 60%
- Annual income of the family should be less than 3, 00,000 Rs.

Mumbal University Regulations for SCHOLARSHIP/ FREESHIP (For SC, ST, NT, DT, SBC & OBC STUDENTS for all Courses)

Eligibility for Scholarship/ Free ship only

- 1. Scholarship for SC/ST Category -- Family annual Income Limit should be up to 1,00,000/-
- 2. OBC/NT/DT/ SBC Category Family annual Income limit must be between 49,000/- to 65290/- (50%) Scholarship
- 3. OBC/NT/DT/ SBC Category Family annual Income limit must be below 49,000/- (100%) Scholarship
- 4. Students from OBC/NT/DT/SBC Category Income above 65,290/- will get Free Ship.
- 5. The students from other than Maharashtra state are not eligible for Scholarship/free ship schemes.

The candidates who want to claim free ship should submit the following documents at the time of admission.

PROCEDURE FOR APPLYING



An application for scholarship should comprise

- (1) One copy of the application for scholarship in the prescribed form (separate Application forms have been prescribed for .fresh. and renewal scholarship)
- (2) One copy of the passport size photograph with signature of the candidate thereon (for fresh scholarship)
- (3) One attested copy of certificates, Diploma, Degree etc in respect of all examinations passed.
- (4) One photocopy of Caste certificate: Original Caste certificate definite income from all sources of last year i. e. 2007-2008. Income Certificate from Tahsildar or Form No.16 A (As per Circular number 1749 Dated 14-6-2008 By Spl. District Social Welfare Officer, Mumbai Suburban.
- (6) Non Creamy layer Certificate for VJ/NT/OBC/SBC.
- (7) Gap Certificate if there is gap in education.
- (8) Residential proof Ration card (Compulsory)
- (9) District change Certificate in case any candidate change his district.
- (10) Death certificate in case father/ Mother expired.
- (11) A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application only duly countersigned by the Head of the Institution concerned, if the application was in receipt of a scholarship under this scheme in the preceding year.
- (12) Application complete in all respects shall be submitted to the Head of the Institution being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose by the Government of State/Union Territory to which the student belong in Accordance with the instructions issued by them from time to time.
- (13) Incomplete applications or applications received after the prescribed Date will not be considered.

Note: If Free ship/ Scholarship not sanctioned from the Govt. of any reason then candidate will have to pay The entire Fees to the Institute.

Maha DBT Regulations for SCHOLARSHIP/ FREESHIP

FOR GENERAL CATEGORY STUDENTS

Eligibility criteria

- 1. The Family annual income should be up to Rs. 8.00 Lac.
- 2. Applicants must belonging to General category.
- 3. Applicants should be residents of Maharashtra.



- 4. No scholarship will be paid to the applicants if he/she accept anoth scholarship/stipend.
- 5. 75% attendance is mandatory for current year.

Documents required by applicants while applying for scholarship are as follows:

- 1. Income certificate
- 2. Certificate of Domicile of Maharashtra
- 3. HSC/SSC/last examination mark sheets
- 4. Gap certificate (in case of gap it is mandatory)
- 5. If applicable father/Guardians death certificate
- 6. Ration card for identify number of children in family
- 7. H.S.C. Leaving Certificate
- 8. Declaration certificate of parents/guardians about number of children beneficiaries
- 9. Fee receipt of current course year.

FOR SC/ST CATEGORY STUDENTS

Eligibility criteria

- 1. The parents/Guardians annual income should be less than or equal to Rs. 2.5 Lacs.
- 2. Applicants should be residents of Maharashtra (not mandatory for ST category).
- 3. If Applicants fails in particular year then he will get the Tuition Fees, Exam Fees and Maintenance allowance of that particular academic year but he/she will not get the benefit until he/she gets promoted to next higher class.
- 4. No scholarship will be paid to the applicants if he/she accept another scholarship/stipend.

Documents required by applicants while applying for scholarship are as follows:

- 1. Caste certificate
- 2. Income certificate
- 3. Domicile certificate(not mandatory for ST applicants)
- 4. HSC/SSC/last examination marksheets
- 5. Gap certificate (in case of gap it is mandatory)
- 6. If applicable father/Guardians death certificate
- 7. Ration card for identify number of children in family
- 8. H.S.C. Leaving Certificate



10. Fee receipt of current course year

FOR SBC/OBC/VJNT CATEGORY

Eligibility criteria

- 1. The parents/Guardians annual income should be less than or equal to Rs. 1.00 Lac.
- 2. Applicants must belong to the SBC/OBC/VJNT category.
- 3. Applicants should be residents of Maharashtra.
- 4. If Applicants fail in a particular year then he will get the Tuition Fees, Exam Fees and Maintenance allowance of that particular academic year but he/she will not get them benefit until he/she gets promoted to the next higher class.
- 5. Only two children i.e. i) any number of girl's applicants allowed. ii) Boys applicants maximum 2 of the same parent will be eligible for the scholarship.
- 6. No scholarship will be paid to the applicants if he/she accept another scholarship/stipend.
- 7. 75% attendance is mandatory for current year.
