The first meeting of the College Development Committee for the academic year 2024-25 was held on Friday, 28th June, 2024 at 12 noon in the College Committee Hall.

The meeting started with the introduction of College Development Committee by Dr. Minakshi Gupta, I/C Principal and Member-Secretary of CDC.

- 1. Review and confirm the minutes of the previous meeting: The member secretary Dr. Minakshi Gupta read the minutes of the CDC meeting held on 27th September, 2023 and the same was reviewed and confirmed by the members.
- 2. Approval for college academic calendar 2024-25: The proposed academic calendar was presented with schedules for both semesters, examination dates, holidays, and events.
- 3. Approval for academic audit: Proposal for conducting the annual academic audit was discussed, covering faculty workload, syllabus completion, student feedback, and departmental documentation.
- 4. Commencement of SY and TY classes:- Second and Third classes were commenced from 19th June 2024 and it was approved by the committee.
- 5. Institutional Preparedness in accordance with National Education Policy 2020: The I/C Principal briefed the Committee about the various initiatives taken up by the institution to sensitize and prepare the teachers and students on NEP implementation.

 - ➤ Deputed Faculty Members to attend various workshops on NEP at various Institutions.
 - > Organized a session on the topic NEP 2020's effect on School Education in India.
 - > Constituted the Electoral Literacy Club and appointed a Nodal Officer.
 - > Organized a Voter registration Drive for the student teachers.

Principal also informed that the institution plans to organize a session on NEP in School Education. Members approved the plan.
